## **Description of first aid measures**

General advice

Show this safety data sheet to the doctor in attendance. Immediate medical attention is required.

**Inhalation** Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical

attention immediately. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
